with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid:

PAYABLE: \$30.00 on the 13th day of each month hereafter, commencing August 13, 1956 and continuing until paid in full, with interest thereon from date at the rate of six per cent, per annum, to be computed and paid semi-annually in advance, until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Cleveland Township and described as follows:

BEGINNING at an iron pin across road 25 feet from joint of Span and Nancy Cruel, and Elmer Poole and running thence S.  $76\frac{1}{2}$  W. 3.08 chains to iron pin; thence N.  $13\frac{1}{2}$  W. 1.72 chains to iron pin, joint corner of John Roberts; thence N.  $76\frac{1}{2}$  E. 3.08 chains to iron pin on road; thence with road, S.  $13\frac{1}{2}$  E. 1.72 chains to the beginning corner.
