ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being near the line of Gantt and Greenville Township, situate, lying and being on the Dunham Bridge Road, near Saluda River and being known and designated as a part of Tract No. 13 and 12 as shown on plat made by Dalton & Neves, October 1932 and recorded in Plat Book "H", at pages 212 and 213 and being the same as shown by a Plat made by Pickell & Pickell, April 8, 1952 and having the following courses and distances:
