All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, situated on the West side of Blue Ridge Drive and the South side of Crestview Circle in the City of Greer, by recent annexation, being all of Lot No. 10 and a small portion of the adjoining Lot No. 9 of Burgiss Hills, according to survey and plat by Piedmont Engineering Service, dated January 21, 1951, recorded in Plat Book Y, pages 96-97, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit: BEGINNIN at the intersection of Blue Ridge Drive and Crestview Circle, and running thence along a curving line of said intersection, the chord of which is N. 13.00 W. 33.7 feet; thence along the South side of Crestview Circle, N. 60.15 W. 168.3 feet to an iron pin, corner of Lot No. 11; thence along the line of Lot No. 11, S. 30.44 W. 141 feet to an iron pin, new corner; thence a new line S. 58.33 E. 184 feet to an iron pin on West side of Blue Ridge Drive; thence along the West side of said drive, N. 34.36 E. 122.5 feet to the beginning corner.
