WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **SEVEN THOUSAND FIVE HUNDRED AND NO/100** DOLLARS (\$ 7500.00), with interest thereon from date at the rate of **five and one-half** per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All ~~that~~ ^{those} certain piece/parcel/or lot/of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of the old Buncombe Road, known and designated as Lots Nos. 97 and 98 on a plat of Colonia Company, recorded in Plat Book "G" at Page 112, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Buncombe Road, corner of Lot No. 96, and running thence with line of said Lot, S. 35-50 W. 185 feet to iron pin in line of Lot No. 95; thence with line of Lot No. 95 N. 58-05 W. 141.2 feet to iron pin; thence N. 42-50 E. 188.4 feet to iron pin on Buncombe Road; thence with the Southern side of Buncombe Road, S. 58-05 E. 111.8 feet to the point of beginning.
