TO ALL WHOM THESE PRESENTS MAY CONCERN:

ANNA A. LOOPER

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **E. E. Martin**.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Seven Hundred Ninety-five and No/100 - - - - -**

DOLLARS (\$ **795.00**),

with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid: **PAYABLE: in monthly installments of \$10.00 each on the first day of each month hereafter and in addition a payment of \$295.00 on October 1, 1956, and the entire balance on August 1, 1957, with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed and paid semi-annually**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **in Greenville Township, near Oddfellows' Orphanage, and having according to a plat recorded in Plat Book F at Page 90, the following metes and bounds, to-wit:**

"BEGINNING at a stake on the Dunham's Bridge Road and running thence along said road S. 30-45 E. 109 feet to a stake on said road; thence N. 32-50 E. 200 feet to stake; thence N. 30-45 W. 109 feet to stake on Hollywood Drive, formerly New Dunham's Bridge Road; thence with Hollywood Drive S. 32-50 W. 200 feet to the beginning, containing 1/2 acre."

Said premises being also shown as Lot 4, Block 3 on page 243 of the County Block Book.

And being the same property conveyed to mortgagor by Sara G. Burdette by deed recorded in Deed Book 455 at Page 309.

This mortgage is junior in lien to a mortgage held by Fidelity Federal Savings & Loan Association in the original amount of \$4500.00, recorded in Mortgage Book 679 at Page 274.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
