WHEREAS, the Mortgagor is well and truly indebted unto E. E. Martin.

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: PAYABLE: in monthly installments of \$10.00 each on the first day of each month hereafter and in addition a payment of \$295.00 on October 1, 1956, and the entire balance on August 1, 1957, with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed and paid semi-annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near Oddfellows! Orphanage, and having according to a plat recorded in Plat Book F at Page 90, the following metes and bounds, to-wit:

"BEGINNING at a stake on the Dunham's Bridge Road and running thence along said road S. 30-45 E. 109 feet to a stake on said road; thence N. 32-50 E. 200 feet to stake; thence N. 30-45 W. 109 feet to stake on Hollywood Drive, formerly New Dunham's Bridge Road; thence with Hollywood Drive S. 32-50 W. 200 feet to the beginning, containing 1/2 acre."
