And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note and mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in Greenville Township, Greenville County, State of South Carolina, in Ward 1 of the City of Greenville, on the Northwest side of Butler Avenue, in the block between Hampton Avenue and Pinckney Street, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Butler Avenue at the corner of an alley (said alley being between this lot and the lot belonging to L. B. Houston, and running Northwesterly from Butler Avenue); thence with the line of Butler Avenue, S. $20\frac{1}{2}$ W. 70 feet, more or less, to an iron pin on said Avenue; thence N. $69\frac{1}{2}$ W. 109 feet to an iron pin; thence N. $60\frac{1}{2}$ W. 57 feet, more or less, to an iron pin on an alley (said alley running northeastwardly between this lot and property now or formerly belonging to the Estate of J. F. Gallivan); thence along said alley, N. $23\frac{1}{2}$ E. 61 feet, more or less, to an iron pin on the South side of the alley first above mentioned; thence with the South side of said alley, S. $69\frac{1}{2}$ E. 161 feet, more or less, to an iron pin on Butler Avenue, the beginning point.
