NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 8-G, and being known and designated as Lot No. 52 and the southeastern half of Lot No. 51 of a subdivision known as Langley Heights, as shown on plat thereof recorded in the R.M.C. office for Greenville County in Plat Book N, at page 133, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the southwest corner of the intersection of Langley Drive and Hawthorne Lane, and running thence along the southwest side of Hawthorne Lane, N. 44-37 W. 95 feet to an iron pin in the center of the front line of Lot No. 51; thence on a line through the center of Lot No. 51, S. 45-40 W. 181 feet, more or less, to an iron pin in the line of Lot No. 47; thence along the line of Lot No. 47, S. 36-00 E. 52.7 feet, more or less, to an iron pin at the corner of Lot No. 47 on the northwest side of Langley Drive; thence along the line of Langley Drive, N. 58-23 E. 193.8 feet to the beginning corner.
