NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successsors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of Warren Court in the City of Greenville, being shown as Lot #3 on a plat of Warren Court recorded in Plat Book CC at page 13 and described as follows:

BEGINNING at a stake on the Southwestern side of Warren Court, 135 feet Northwest from Webster Road at the corner of Lot 2, and running thence with the lines of Lots 2 and 1, S. 40-27 W. 150.8 feet to a stake; thence N. 47-00 W. 70.7 feet to stake at the corner of Lot 4; thence with the line of said lot N. 40-42 E. 147.4 feet to a stake on Warren Court; thence with the Southwestern side of said Court, S. 49-33 E. 70 feet to the beginning corner.

Being the same property conveyed to mortgagor by deed recorded in Deed Book 514 at page 202.
