NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Rasor Drive, near the City of Greenville, being a portion of lot # 3, as shown on plat of Mountain View Acres, recorded in Plat Book I at Pages 69 and 70, and described as follows:

"BEGINNING at an iron pin on the Eastern side of Rasor Drive, at the joint front corner of lots # 3 and 4, and running thence with the line of lot # 4, S. 71-17 E. 301.1 feet, more or less, to an iron pin in line of lot # 4; at the corner of property conveyed to Aiken; thence with the line of Aiken property, S. 18-43 W. 75 feet to an iron pin; thence N. 71-17 W. 300 feet, more or less, to an iron pin on the East side of Rasor Drive; thence with said Drive, approximately N. 18-43 E. 75 feet to the beginning corner."
