called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Nine Thousand Three Hundred and No/100** Dollars (\$ 9,300.00), with interest from date at the rate of **four and one-half per centum (4½ %)** per annum until paid, said principal and interest being payable at the office of **General Mortgage Co.** in **Greenville, S. C.**, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of **Fifty-one and 71/100** Dollars (\$ 51.71), commencing on the first day of **October**, 1956, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **September**, 1981.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of **Greenville** State of South Carolina;

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, within the corporate limits of the City of Greenville, and being known and designated as Lot No. 10 of the property of W. T. Patrick and Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book EE, at page 157, and having according to said plat and also according to a more recent plat prepared by Piedmont Engineering Service, dated August 20, 1956, and entitled "Property of Albert R. Power & Mary H. Power, Greenville, S. C.", the following metes and bounds:

BEGINNING at a point on the Eastern side of Keith Drive at the joint front corner of Lots 9 and 10 and running thence N. 72-48 E. 175 feet to a point at the joint rear corner of Lots 9 and 10; thence S. 17-12 E. 70 feet to a point at the rear corner of Lot 10; thence S. 74-45 W. 181.3 feet to a point on the Eastern side of Keith Drive at the joint front corner of Lots 10 and 11; thence with the Eastern side of Keith Drive, N. 11-19 W. 64 feet to the point of beginning.
