ALL of that parcel or tract of land in Glassy Mountain Township of Greenville County, South Carolina, known and designated as Lot No. 5 of the Estate of J.M. McClure Property, as designated by his last will and testament which is on file in the Probate Court for Greenville County, and having the following courses and distances: BEGINNING on a stake on a gulley, corner with tract devised to Will McClure, and runs thence S. 77 3/4 W. 9.08 chains to a stake; thence N. 20 W. 13.00 chains to a stake; thence N. 77 3/4 E. 20.40 chains to a stake; thence S. 26 E. 3.00 chains to a stake on or in branch in pasture; thence S. 15 W. 7.43 chains to a stake; thence S. 3 E. 1.30 chains to a stake in branch; thence S. 70 W. 7.30 chains to a stake; thence S. 37 E. 1.50 chains to a stake and the beginning corner, and being the same property conveyed to the mortgagors by Millie blackwell by deed of even date and to be recorded herewith.
