SEND GREETINGS:

Whereas, I the said Harold N. Pittman .
in and by my certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to
HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina,
in the full and just sum of **Twenty Five Hundred and no/100's** Dollars,

S. 79 W. 311 feet to point of BEGINNING; this being the same land conveyed to Harold N.

ministrators to warrant and forever defend all and singular the said premises unto the said HOME BUILDING & LOAN AS-
SOCIATION, its Successors or Assigns, from and against myself (ourselves), my (our) Heirs, Executors, Administrators and As-
signs, and every person whomsoever lawfully claiming or to claim the name or any part thereof.
