To All Whom These Presents May Concern:

I, Ella P. Groce hereinafter called
the Mortgagor, SEND GREETING:

with interest thereon from maturity at the rate of six per centum per annum, to be computed and paid semi-annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Poinsett Street (formerly National Highway) in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 5 of the R. L. Ford Property, and having the following courses and distances, to wit:

Beginning at an iron pin on the north side of W. Poinsett Street, corner of Lots Nos. 5 and 6, and running thence along line of same, N. 8.27 E. 181½ feet to an iron pin on line of Lot No. 7; thence along the line of Lot No. 7, S. 87.50 W. 70 feet to an iron pin, corner of Lot No. 4; thence along the line of Lot No. 4, S. 8.27 W. 181½ feet to an iron pin on edge of W. Poinsett Street; thence along said street N. 87.50 E. 70 feet to the beginning corner.
