Whereas, **we**, the said **Emma B. Faulkner (Formerly Emma B. McCarter) and J. Vance Faulkner,** note in writing, of even date with these
in and by **our** certain **promissory**
presents, **are** well and truly indebted to **The Peoples National Bank of Greenville, S.C.,**
in the full and just sum of **Four Thousand and No/100ths (\$4,000.00) Dollars,**

to be paid in quarterly installments of \$200.00 each, beginning on the 18th day of December, and continuing thereafter until paid in full,

with interest thereon from **date**

at the rate of **six** per centum per annum, to be computed and paid **quarterly**

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of his or its interests to place, and the holder should place, the said note or this mortgage, in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land with the improvements thereon situate, lying and being in Greenville Township, Greenville County, State of South Carolina, in the Town of West Greenville, and being designated as a portion of Lots 9 and 11, as shown on plat of D. T. Smith's lots made by W.D. Neves, April 17, 1918, and recorded in the R.M.C. Office for Greenville County in Plat Book F, at page 27, and being more particularly described as follows:

BEGINNING at a pin on the West side of a paved roadway known as Lindall Avenue, joint corners of Lots 10 and 11, and running thence N. 50-20 E. with said avenue, 85 feet, more or less, to a point at the Southeastern corner of a triangular strip conveyed by T.A. Roe to M.W.
