NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern corner of Welcome Road and Worley Road near the City of Greenville, and according to a plat of the property of George T. Tucker made by Woodward Engineering Company in January, 1955, and recorded in Plat Book JJ at Page 36, is described as follows:

"BEGINNING at a stake at the southeastern corner of Welcome Road and Rowley Road and running thence with the southern side of Worley Road N. 74-55 E. 100 feet to a stake; thence S. 22-20 W. 258 feet to a stake; thence N. 71-08 W. 79.7 feet to a stake on Rowley Road; thence with the eastern side of said road N. 22-20 E. 202 feet to the beginning corner."
