DOLLARS (\$5000.00 with interest thereon from date at the rate of four & per centum per annum, said principal and interest to be Payable five years after date with interest thereon from date at the rate of four and one-half (42%) per cent. per annum, to be computed and paid quarterly, with the privilege of anticipating all or any part of the unpaid balance on any interest date

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the east side of North Main Street, and described as follows:

*EEGINNING at a pin on the east side of North Main Street, corner of F. W. Symmes lot, 40 feet south of the southeast corner of N. Main Street and Oak Street, and running thence with the line of Symmes lot S. 66-04 E. 114.42 feet to pin; thence S. 18-30 W. 6'4" to pin; thence N. 68-64 W. 13' 6.5" to pin; thence S. 18-30 W. 18 feet to pin corner of lot now or formerly owned by Wharton; thence with line of Wharton let N. 68-04 W. 100 feet to pin in East side of N. Main St.; thence with N. Main Street N. 19-51 E. 28.21 feet to point of beginning."
