I, C. B. Loftis hereinafter called the Mortgagor, SEND GREETING:

Linder of W.M. Shockley Estate and having the following Metes and Bounds:

BEGINNING at an iron pin on south side of Highway on property line of Taylor Lumber Co. and running thence along Highway S. 86-32 W. 65 feet to iron pin; thence S. 6-43 E. 130.5 feet to iron pin on R.O.W. of Southern Railway; thence N. 79-00 E. 51.4 feet to iron pin on Taylor Lumber Co. Line; thence N. 0-21 W. 125 feet to beginning.
