WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fourteen Thousand Two Hundred Dollars (\$14,200.00), with interest from date at the rate of Four & one-half per centum (4½%) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy-eight and 95/100----- Dollars (\$ 78.95), commencing on the first day of December, 1956, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of November, 1981.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the East side of Azalea Court near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 26 on plat of Section 2, of North Gardens, made by Dalton & Neves, Engineers, January, 1955, recorded in the RMC Office for Greenville County, S. C., in Plat Book EE, page 103; said lot fronting 80 feet along the East side of Azalea Court, running back to a depth of 159 feet on the North side, to a depth of 158.2 feet on the South side, and being 80 feet across the rear.
