SEND GREETING:

Whereas, I , the said W. Freddie Mayson
in and by my certain promissory note in writing, of even date with these

Presents, am well and truly indebted to The S. C. National Bank of Charleston, As
Executor & Trustee under will of E. R. Parker, Deceased, & Walter W. Goldsmith
in the full and just sum of ----Four Hundred Ninty-Five and 0/100 Dollars

(\$495.00) , to be paid \$25.00 monthly beginning October 25, 1956.

Said \$25.00 payment includes interest at 6%, balance of remainder of each \$25.00
payment to apply to principal.

, with interest thereon from Date
at the rate of 6 per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage

gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

South Carolina National Bank of Charleston, as Executor and Trustee under the will
of E. R. Parker, Deceased, and Walter W. Goldsmith,

ALL that piece, parcel or tract of land, situate, lying and being on the North side
of Stevenson Lane, in Gantt Township, Greenville County, S. C. being shown as
Lot No. 22, on plat of Dixie Farms, made by Dalton & Neves, Engineers, December,
1939, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "L"
at page 5, and having, according to said plat, the following metes and bounds, towit:

BEGINNING at an iron pin on the North side of Stevenson Lane at joint front corner
of Lots 21 and 22 and running thence with the line of lot 21, N. 26-14 W. 249.8 feet
to an iron pin; thence S. 63-46 W. 160 feet to an iron pin; thence with the line of lot
23, S. 26-14 E. 249.8 feet to an iron pin on the North side of Stevenson Lane; thence
with the North side of Stevenson Lane, N. 63-46 E. 160 feet to the beginning corner.
