LOT NO. 18: BEGINNING at an iron pin on the eastern edge of Mauldin Circle, joint front corners of Lot No. 18 and a lot marked "sold", and running thence S. 65-57 E. 145.9 feet to an iron pin at a rear corner of Lot No. 25; thence along the line of that lot, N. 23-30 E. 80 feet to an iron pin at a rear corner of Lot No. 19; thence along the line of that lot, N. 65-57 W. 145.9 feet to an iron pin on the eastern edge of Mauldin Circle; thence along the eastern edge of Mauldin Circle; thence along the eastern edge of Mauldin Circle, S. 23-30 W. 80 feet to the beginning corner.
