NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Webster Street in the City of Greenville, being more particularly described as follows:

"BEGINNING at a stake on the southern side of Webster Street 100 feet westward from the intersection of Boyce Street and Webster Street and at the northwestern corner of Lot No. 1 and running thence along Webster Street N. 71-00 W. 95 feet to stake 1 foot eastward from the corner of Lot No. 3; thence S. 19 W. parallel with line of Lot No. 3 and at all points 1 foot eastward from said line 122 feet to a stake on right-of-way of C. & W. C.
