All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the Southern side of McLendon Drive, near the City of Greenville, being shown as lot # 98 of Section I, on a plat of Cakcrest, recorded in Plat Book GG at Page 131, and described as follows:
