"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

at the Southwestern corner of the intersection of Mabel Avenue and McKinney Lane, being shown as Lot No. 47 on Plat of the property of James M. Edwards, made by Dalton & Neves in February 1955, recorded in the R.M.C. Office for Greenville County in Plat Book II, at page 121, and having, according to said Plat, the following metes and bounds, to-wit:
