RALPH HINTON (SAME AS J. R. HINTON) (hereinafter referred to as Mortgagor) SEND(S) GREETING:

DOLLARS (\$1500.00), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the western side of Flora Avenue in Greenville Township, near the City of Greenville, being known and designated as Lot No. 40 on Map No. 2 of Camilla Park prepared by W. J. Riddle dated December, 1943, recorded in Plat Book M at Page 85, according to said plat having the following metes and bounds:

"BEGINNING at an iron pin on the western side of Flora Avenue at the front corner of Lot 39 and running thence with the line of said lot N. 80-44 W. 200 feet to an iron pin; thence with the rear line of Lot 29 N. 9-16 E. 80 feet to an iron pin rear corner of Lot 41; thence with the line of said lot S. 80-44 E. 200 feet to an iron pin on the western side of Flora Avenue; thence with the western side of said Avenue S. 9-16 W. 80 feet to the beginning corner."

Being the same property which was conveyed to the mortgagor by deed of Lloyd H. Hinton recorded in Deed Book 363 at Page 311.
