WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Sixteen Thousand, Eight Hundred and No/100 - - - - -

(\$\frac{16,800.00}{}\)) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

One Hundred, Ten and 88/100 - - - - - - - - - upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal. The last payment on this mortgage, if not sooner paid, will be due and payable twenty (20) years after date. The note further provides that if at any time any portion be due and payable twenty (20) years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

M. C. office for Greenville County in Plat Book Y, at page 39, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Greenwood Avenue at the corner of Lot No. 33, and running thence N. 84-00 E. 258.5 feet to an iron pin at the rear corner of said lot; thence N. 4-45 W. 198 feet to an iron pin at the rear corner of Lot 35; thence S. 84 W. 262.7 feet to an iron pin on the eastern side of Greenwood Avenue at the front corner of Lot 35; thence along the eastern side of Greenwood Avenue, S. 6-0 E. 200 feet to the beginning corner; being the same conveyed to me by Walton H. Clifton and Juanita M. Clifton by deed dated February 24, 1954 and recorded in the R. M. C. office for Greenville County in Vol. 494, at page 483."
