RELEASE OF MORTGAGE LIEN

FOR VALUE RECEIVED, I, Glendean J. Riley do hereby release and forever discharge the following described property from the lien of that mortgage given to me by W. H. Alford in the original amount of \$7000.00, dated June 8, 1956, and recorded in the R. M. C. Office for Greenville County in Volume 681, at page 79: All of that lot of land with the buildings and improvements thereon situate on the Southeast side of Old Spartanburg Road, about five miles east of the City of Greenville, in Chick Springs Township, Greenville County, South Carolina, fronting 200 feet on the Old Spartanburg Road and having a depth of 200 feet, and being more fully described according to plat of property of W. Hubert Alford made by C. C. Jones, Engineer, April 21, 1955, and recorded in the R. M. C. Office for Greenville County in Plat Book "CC", at page 196, reference to said plat being hereby made for a more complete description. ALSO all of that certain piece, parcel or lot of land on said Old Spartanburg Road, being known and designated as Lot No. 1, on plat of Property of W. H. Alford made by C. C. Jones & Associates, Engineers, dated March 3, 1956, not yet recorded; said lot having the following metes and bounds: BEGINNING at a point 240 feet in a northerly direction from Barry Drive, said point being on the Old Spartanburg Road; and running thence along Old Spartanburg Road N. 33-52 E. 120 feet to point joint corner of Lots Nos. 1 and 2; thence along the joint line of said Lots Nos. 1 and 2, S. 52-23 E. 200 feet to point in line of Lot No. 8; thence S. 33-40 W. 106.8 feet to point in line of Lot No. 9; thence N. 56-08 W. 200 feet to the point of beginning. Said mortgage shall remain in full force and effect, except as to property described herein.

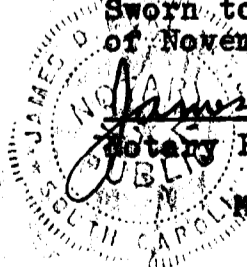
