WHEREAS: I, **GEORGE MICHAEL ROBINSON,**

Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

CANAL INSURANCE COMPANY

, a corporation organized and existing under the laws of **State of South Carolina**, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Eleven Thousand, Three Hundred and No/100 Dollars (\$11,300.00)**, with interest from date at the rate of **four and one-half per centum (4½%)** per annum until paid, said principal and interest being payable at the office of **Canal Insurance Company** in **Greenville, South Carolina**, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of **Sixty-two and 81/100 Dollars (\$ 62.81)**, commencing on the first day of **February**, 1957, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **January**, 19 82.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of **Greenville**, State of South Carolina;

ALL that certain piece, parcel or lot of land near the City of **Greenville**, being known and designated as Lot No. 43 of **Chestnut Hills**, being in **Greenville County**, State of South Carolina, plat of which is recorded in the R.M.C. Office for **Greenville County, S. C.**, in Plat Book **GG** at page 35, and according to said plat, having the following metes and bounds:

BEGINNING at a point on the Western side of Farmington Road at the joint front corners of Lots Nos. 42 and 43, which point is 190 feet from the intersection of Farmington Road and Chipley Lane and running thence with Farmington Road, S. 37-01 E. 60 feet to a point; thence continuing with said road, S. 0-30 E. 60 feet to a point; thence N. 80-34 W. 155 feet; thence N. 22-38 E. 18 feet to the joint rear corner of Lots Nos. 42, 43 and 84; thence N. 58-50 E. 127.6 feet to a point on the Western side of Farmington Road, the point of beginning.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
