WE, CECIL E. NALLEY AND ELLEN S. NALLEY SEND GREETING:  
Whereas We, the said Cecil E. Nalley and Ellen S. Nalley  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to Lloyd W. Gilstrap and Levis L. Gilstrap  
in the full and just sum of Three Thousand and Ten Dollars and 00/100 (\$3,010.00)  
to be paid monthly, in equal installments of \$25.00, commencing  
on October 1, 1959, and a like amount on the first day of each month thereafter until  
paid in full, with full rights of anticipation.

, with interest thereon from date  
at the rate of 6 per centum per annum, to be computed and paid monthly  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and  
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the  
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its  
maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity  
it should be deemed by the holder thereof necessary for the protection of his interests to place and  
the holder should place the said note or this mortgage in the hands of an attorney for any legal  
proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses  
including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness,  
and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted,  
bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said  
Levis L. Gilstrap and Lloyd W. Gilstrap, their heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in the City of Greenville  
County of Greenville, State of South Carolina on the western side of Summitt Drive and  
being known and designated as Lot No.9, Block 1 on a plat of Section A of Parkvale pre-  
pared by Dalton & Neves dated July, 1940 and recorded in the R. M. C. Office for Greenville  
County in Plat Book "K", at page 52 and having, according to said plat, the following  
metes and bounds, to-wit:

BEGINNING at a stake on the western side of Summitt Drive 615 feet north from West View  
Avenue at corner of Lot No. 8 and running thence with said lot N. 88-45 W. 180 feet to  
a stake a corner of Lot No.10; thence with the line of said lot N. 12-00 E. 70 feet to  
a stake; thence S. 89-00 E. 175 feet to a stake on Summitt Drive; thence with the west-  
ern side of Summitt Drive S. 8-30 70 feet to the beginning corner.
