are incorporated herein by reference, in the principal sum of Thirteen Thousand and No/100
Dollars (\$13,000.00), with interest from date at the rate of Five & three-fourths
(5 & 3/4%) per annum until paid, said principal and interest being payable at the office of
General Mortgage Co. in Greenville, South Carolina,
or at such other place as the holder of the note may designate in writing, in monthly installments of

situate on the Southwest side of Hill Street, near the City of Greer,
in Greenville County, South Carolina, being shown as Lot No. 11 on
plat of property of J. Wayman Smith, made by H. S. Brockman, November 9,
1948, recorded in the RMC Office for Greenville County, S. C. in Plat
Book FF, page 534, said lot fronting 86 feet along the Southwest side
of Hill Street, running back to a depth of 213.98 feet on the Northwest
side, to a depth of 216.4 feet on the Southeast side of said lot along
Douglas Street, and being 85.1 feet across the rear.
