All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and on the Eastern side of South Hudson Street in the City of Greenville; said lot of land being described by metes and bounds as follows, to-wit:

BEGINNING at an iron pin at the corner of an Alley on Hudson Street and running thence in a Southern direction with Hudson Street Fifty-Seven and One-Half feet to an iron pin on the line of property of Epstin; thence in an Easterly direction with said Epstine's line One Hundred and Fifty feet to an iron pin; thence in a Northerly direction with the line of fence Fifty-Seven and One-Half feet to an iron pin in the Southern line of said Alley; thence in a Westerly direction with the line of said Alley One Hundred Fifty feet to the beginning corner on Hudson Street.
