C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

near the City of Greenville, on the west side of Bahan Street, known as lot # 22 on Plat # 2 of property of W.S. Bradley, prepared by Dalton & Neves in April 1945, recorded in the RMC Office for Greenville County in Plat Book 0 at Page 169, and , according to said plat, being more particularly described as follows:

BEGINNING at an iron pin on the west side of Bahan Street, at the front corner of lot # 21, and running thence with the line of said lot, N. 88-10 W. 322.9 feet to an iron pin; thence S.0-31 W. 100 feet to an iron pin at the rear corner of lot # 23; thence with the line of said lot, S. 88-10 E. 325 feet to an iron pin on the west side of Bahan Street; thence with the west side of said Street, N. 0-42 W. 100.1 feet to the point of beginning.
