NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of **Three Dollars (\$3)** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of **South Carolina**:

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being near the City of **Greenville**, in the County of **Greenville**, State of **South Carolina**, being known and designated as **Lot #273** as shown on Plat of **Robert J. Edwards**, which plat is recorded in the **RMC Office** for **Greenville** County, in **Plat Book EE**, page **61**, and having, according to said plat, and according to a more recent plat of **T. C. Adams, Reg. Eng.**, under date of **November 4, 1959**, entitled "**Property of George S. Clark**," the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north western side of **Barbara Avenue** at the joint front corner of **Lots #273 and #274**, said iron pin being **341.4** feet in a north easterly direction from the intersection of **Barbara Avenue** and **Cherokee Drive**, and running thence along **Barbara Avenue S. 43-0 W. 100** feet to an iron pin; thence along the lines of **Lots #272, 271 and 270 N. 47-0 W. 300** feet to an iron pin; thence along the line of **Lot 262 N. 43-0 E. 100** feet to an iron pin, joint rear corner **Lots 273 and 274**; thence **S. 47-0 E. 300** feet to an iron pin at the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
