WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C.; (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **THREE THOUSAND NINE HUNDRED AND NO/100**

**DOLLARS (\$ 3900.00)**, with interest thereon from date at the rate of **six and one-half** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Bates Township**, situate on the western side of the Little Texas Road a few hundred feet south of the intersection of Tigerville Road as shown on plat recorded in plat book NN at page 164 of property of Leonard D. Nix Estate made by Terry T. Dill dated March 18, 1959 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Little Texas Road running to Enoree at the corner of property of Juanita L. Cox which iron pin is situate 361 feet south of the center line of Tigerville Road and running thence S 70-25 W, along the Cox line, 148.6 feet to an iron pin; thence along property of Patrick S 23 E, 83.1 feet to an iron pin; thence along the line of Ruth Nuckles N 68-02 E, 147.8 feet to an iron pin on said road; thence with said road N 22-26 W, 77 feet to the point of beginning.
