To All Whom These Presents May Concern: We, D.F. Smith, Jr. and Thelma H. Smith,

hereinafter called

the Mortgagor(s), SEND GREETING:

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee, The First National Bank of Greer, its Successors and Assigns:

All that certain parcel or lot of land situated on the north side of Buddy Avenue near Pleasant Grove Baptist Church, about one mile southward from the City of Greer, Chick Springs Township of Greenville County, State of South Carolina, and being Lot No. 31 of Woodland Heights, property of the I.M. Wood Estate, according to survey and plat by H.S. Brockman, Surveyor, dated October 28, 1955, recorded in Plat Book GG, page 151, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the north side of Buddy Avenue, corner of Lots Nos. 31 and 32, and running thence N. 39-15 W. 190 feet; thence N. 45-18 E. 100 feet to an iron pin, corner of Lot No. 31; thence S. 39-15 E. 190 feet to an iron pin on the north side of Buddy Avenue; thence along said Avenue, S. 45-18 W. 100 feet to the beginning corner.
