TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Leonard O. King,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the southwestern side of Cardinal Drive, Chick Springs Township, near the City of Greenville, shown as Lot No. 48 on plat of Cardinal Park, recorded in Plat Book W at Page 27, and according to said plat being more particularly described as follows:

"BEGINNING at an iron pin on the southwestern side of Cardinal Drive, front corner of Lot No. 47, and running thence S. 64-02 W. 139.3 feet to iron pin; thence S. 25-58 E. 70 feet to an iron pin, rear corner of Lot No. 49; thence with line of said lot N. 64-02 E. 139.3 feet to iron pin on the southwestern side of Cardinal Drive; thence with the southwestern side of said Drive N. 25-58 W. 70 feet to the beginning corner, being a portion of the property conveyed to the mortgagor by deed recorded in Volume 448 at Page 327."
