Service, March 28, 1956, recorded in the RMC Office for Greenville County,
S.C. in Plat Book GG, page 187, said lot fronting 80 feet along the
Southwest side of Pine Creek Drive, and running back to a depth of 153.0
feet on the Southeast side, to a depth of 150 feet on the Northwest side
