TO ALL WHOM THESE PRESENTS MAY CONCERN:

John D. Pritchard-Barrett (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot #60, of a subdivision known as Thornwood Acres, Section 2, property of Williams Land Company, Inc., according to a plat prepared by J. Mac Richardson, Engineer, dated April, 1959, plat of which is recorded in the RMC Office for Greenville County, in Plat Book MM at page 105, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 60 and 22, and running thence along the line of these lots, S. 74-55 W. 175 feet to an iron pin; running thence S. 15-05 E. 53.9 feet to an iron pin; thence S. 41-45 E. 130 feet to an iron pin at the joint rear corner of lots 60 and 61; running thence N. 65-25 E. 116.5 feet to an iron pin in the line of lot 61; running thence N. 11-57 E. 72 feet to an iron pin on the southern side of Thornwood Drive; thence along the southern side of Thornwood Drive; thence along the southern side of Thornwood Drive, N. 28-25 W. 91 feet to an iron pin, point of beginning.
