SEND GREETING:

, to be paid in equal monthly installments of Ten Dollars (\$10.00) per month commencing December 1st, 1959, and each consecutive month thereafter, with interest at six percent (6%) per Annum, payments to be applied first to interest, which will be computed monthly, and then to principal until paid in full, with the privilege of acceleration.

, with interest thereon from Date

at the rate of 6 per centum per annum, to be computed and paid Monthly

until paid in full; all interest not paid when due to bear
