NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot No. 82 on a plat of lands of Pride, Patton Land Co. made by R. E. Dalton, Eng., and recorded in office of R. M. C. for Greenville County in Pat Book E at page 249, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Goodrich Street, corner of Lot No. 81, and running thence with the line of Lot No. 81, S. 36-15 W. 208.4 feet to iron pin, corner of Lots 81, 48 and 47; thence with line of Lot No. 47 S. 59-23 E. 60.3 feet to iron pin, corner of Lot No. 83; thence with line of Lot No. 83, N. 36-15 E. 214.2 feet to pin on Goodrich Street; thence with Goodrich Street N. 64-49 W. 61.1 feet to the beginning corner.
