in and by OUR certain promissory note, in writing, of even date with these presents, are well and truly indebted to WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION in the full and just sum of TEN THOUSAND ONE HUNDRED FIFTY & no/100--- (\$10,150.00) Dollars, with interest at the rate of six (6 %) per centum per annum, to be repaid in installments of

Eighty-five and 67/100--- (\$ 85.67) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.
