WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-Five Hundred and no/100

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Chick Springs Township, at the northwest corner of the intersection of Lee Road and Sutton Drive, being shown as lots # 51 and 52 of Block D on plat of Buena Vista Subdivision, recorded in the RMC Office for Greenville County in Plat Book W at Page 11, and described as follows:

BEGINNING at an iron pin at the northwest corner of the intersection of Lee Road and Sutton Drive, and running thence along the western side of Sutton Drive, N. 9-43 W. 151.2 feet to an iron pin at the corner of lot # 31; thence with the line of lot # 31, S. 73-08 W. 75.6 feet to an iron pin at the rear corner of lot # 53; thence with the line of lot # 53, S. 9-43 E. 151.2 feet to an iron pin on Lee Road; thence with the northern side of Lee Road, N 73-08 E. 75.6 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
