WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Five Hundred and no/100

DOLLARS (\$ 7,500.00), with interest thereon from date at the rate of 6 1/2 per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as lot 1 on plat of Blue Berry Park recorded in the R.M.C. Office for Greenville County in plat book BB at page 18 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Hunts Bridge Road, at the corner of lot no. 2 and running thence S 83-26 W, 141.3 feet to an iron pin; thence S 72-38 W, 241.8 feet to an iron pin in the rear corner of lot no. 9; thence N 3-05 E, 214.7 feet to an iron pin at the rear corner of lot no. 13; thence N 84-26 E, 341.2 feet to an iron pin on Hunts Bridge Road; thence with said road S 7-10 E, 161.2 feet to an iron pin at the point of beginning a dn being a portion of that property conveyed to me in deed book 186 at page 21. This description may vary some on Hunts Bridge Road by virtue of the fact that said road has been widened.
