All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 50 on revised plat of Paris View subdivision prepared by Dalton & Neves, Engineers, October 1957 recorded in the RMC Office for Greenville County, S. C. in plat book QQ page 26, said lot having a frontage of 88 feet on the northwest side of Montis Drive, formerly Paris View Drive, a depth of 171.2 feet on the southwest side, a depth of 171 feet on the northeast side and a rear width of 88 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
