(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-seven Hundred and No/100 ----- DOLLARS (\$3700.00), with interest thereon from date at the rate of six and one-half (6½%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Maco Terrace in the City of Greenville, being shown as Lot 29A on plat of property of Central Realty Corporation recorded in Plat Book P, Page 51, and described as follows:

BEGINNING at a stake on the western side of Maco Terrace at the corner of Lot 28A and running thence with the western side of said Terrace S. 36-05 E. 55 feet to a stake at corner of Lot 30A; thence with the line of said lot S. 54-30 W. 145 feet to a stake; thence N. 36-05 W. 55 feet to a stake at the corner of Lot 28A; thence with the line of said lot N. 54-03 E. 145 feet to the beginning corner.
