J. A. Henry as Committee for Willie Gordon, his successors and assigns forever:

All those certain pieces, parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the southern side of the Old Buncombe Road, known and designated as Lots Nos. 97 and 98 on a plat of Colonia Company, recorded in Plat Book "G" at Page 112, and having, according to said plat, the following metes and bounds, to-wit:
