To All Whom These Presents May Concern:

SEND GREETING:

Whereas, we, the said J. D. and Macie Blackwell  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to John T. Wood  
under the conditions set out below:

That the Mortgagors, J. D. and Macie Blackwell will pay to  
Travelers Rest Building and Loan the sum of Six Hundred (\$600.00)  
Dollars, and in the further consideration that they, the Mortgagors,  
are to install a bathroom in a house on Campbell's Mill Road, on property  
purchased from Hugh Hawkins Donnan, payments to be completed within 18  
months, with interest thereon from None

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,

gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

John T. Wood, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Glassy Mountain Township,  
Greenville County, State of South Carolina, beginning on an iron pin in  
West line of road leading from Landrum to Ballew's Mill at the Southwest  
corner of Lot No. 7, as shown on Plat of J. J. Gentry, Jr., made by  
W. P. Marrow, September, 1954, and now owned by Mortgagors, running with  
line of road South 43-23, West 100 feet to corner of Lot No. 5; thence  
with line of road South 19-36 West 100 feet to corner of Lot No. 4;  
thence with line of Lot No. 4 North 74-52 West 103.5 feet to a stake  
in Ballew's line; thence with Ballew's line North 46-48 East 147 feet to  
corner of Lot No. 6; thence with Ballew's line North 46-48 East 106.8  
feet to corner of Lot No. 7; thence with line of Lot No. 7 South 45 East  
122 feet to the beginning point.
