WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand and no/100

DOLLARS (\$ 7,000.00), with interest thereon from date at the rate of six and one-half per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in Bates Township, in or near Travelers Rest, S. C., being a portion of the property of Cornelia Coleman Hawkins which was originally a portion of the property of I. W. and Ollie Coleman as shown on plat by Woodward Engineering Co., dated November 1957, in plat book UU at page 23 and according to plat by Terry T. Dill, dated April 18, 1960, in plat book UU at page 23, and having, according to plat by Terry T. Dill, the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Batson Road (also known as Hawkins Drive) at the corner of the property of E. Montgomery and running thence along said property N 14-28 E, 54 feet to an iron pin; thence N 14-05 E, 279 feet to an iron pin in the line of property of Sally Morgan; thence S 74-31 E, 120 feet to an iron pin; thence along the property of Cornelia C.
