WHEREAS, the Mortgagor is well and truly indebted unto

DOUGLAS WILSON & CO., a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of FOURTEEN THOUSAND AND NO/100---- Dollars (\$14,000.00), with interest from date at the rate of five and three-fourths per centum (5 3/4%) per annum until paid, said principal and interest being payable at the office of C. All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, known and designated as part of Lot 40, Section B, plat of Stone Land Co., plat of which is recorded in Flat Book A, pages 337-345 and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Westerly side of Townes Street at the corner of an alley and running thence along the alley N 83-13 W 104.4 ft. to an iron pin; thence S 1-41 W 100 ft. to an iron pin; thence S 83-13 E. 104.4 ft. to an iron pin on Townes Street; thence, along Townes Street N 1-41 E. 100 ft. to an iron pin, the point of beginning.
