C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Ten Thousand Nine Hundred and No/100ths -----**
DOLLARS (\$ 10,900.00), with interest thereon from date at the rate of **six (6%)-----**
per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 220 as shown on a plat prepared by J. Mac Richardson, RLS, dated May 1960, entitled "Final Plat, Section Three, Orchard Acres," recorded in the R. M. C.
